## VI – REGISTRATION OF RIDERS

All athletes & horses participating in any International Eventing competition must be registered with the FEI (See GR Art. 113, Art. 511.1 & 511.2).

# VI – QUALIFICATION OF COMPETITORS & HORSES (Art. 506)

Each NF must certify the minimum eligibility requirements of each horse and athlete and list the competitions which enabled horse and athlete to qualify, according to the qualification procedure established for each star level as laid out in Art. 506. Relevant level and criteria must be included in the schedule.

#### **Principles**

In order to compete at an international event, an athlete and horse must have obtained the minimum eligibility requirements at a number of events at a lower level.

The requirements are laid out below. With the approval of the FEI and their own NF, OCs may impose additional qualifications for horses and/or athletes, which must be published in the schedule.

#### 1.2. Minimum eligibility requirements

The minimum eligibility requirements are achieved by completing a competition within minimum parameters of all round performance. As follows:

- Dressage Test: not more than 75 penalty points;
- Cross-Country Test:
- From 2009 onwards, the results at obstacles at International events need to include, where applicable, a clear round (0 penalties) at obstacles for CICs events and maximum 20 penalties at a CCI.
- Not more than 90 seconds exceeding the optimum time in the Cross. At 4\* events, the maximum time by which the optimum time may be exceeded is 120 seconds; and
- Jumping Test: not more than 16 penalties at obstacles.

#### 1.3. Certification of Qualification for Events

1.3.1. All NFs, including the host nation, are responsible to certify that athletes and horses entered by them in international events are correctly qualified in accordance with all the requirements of the Rules.

- 1.3.2. All qualifying events must be identified, and any national events must be certified as of at least the equivalent standard of difficulty as the relevant international star level of competition.
- 1.3.3. The Technical Delegate or his nominee shall check that all horses and athletes starting at all International events are properly certified as qualified by their NF or duly exempted in accordance with this article.

#### 1.4. Qualifying Period and Deadline

- 1.4.1 Minimum eligibility requirements for CIOs, CCIs and CICs must be obtained in the calendar year in question or the 2 preceding calendar years.
- 1.4.2 The Minimum Eligibility Requirement at a CCI must be obtained at least 24 days before the Cross Country test of the event for which it is needed; a Minimum Eligibility Requirement at a CIC must be obtained at least 10 days before the event for which it is needed.
- 1.4.3 Minimum eligibility requirements may be achieved as a combination or separately by athlete and horse.
- 1.4.4 Where a Minimum Eligibility Requirement at a CIC is specified, one Minimum Eligibility Requirement at a CCI of the same level is equally acceptable.

#### 2. VETERINARY EXAMINATIONS, HORSE INSPECTIONS & PASSPORT CONTROLS

This visit shall be carried out in **May**, 18<sup>th</sup> 2011 from 2.00p.m onwards in accordance with the Veterinary Regulation (Art. 1011) and the Rules for Eventing (Art. 518.1 for the CCIs & 518.2 for CICs).

#### Art. 511.2.2

Every horse entered at CCNs, CICs\*\*/\* and CCIs\*\*/\* in a foreign country, and all horses entered for CICs\*\*\*, CCIs\*\*\*\*/\*\*\*, CCIOs, Championships, Regional and Olympic Games, whether at home or in foreign countries, must have an official FEI Passport, or a National Passport approved by the FEI, as a means of identification and to establish ownership.

#### Art. 511.2.3

Horses taking part in CCNs, CICs\*\*/\* and CCIs\*\*/\* in the country in which they are resident are not required to have such a passport as mentioned in Paragraph 2.2 above. All such horses must be properly registered with their NF and identifiable and, unless there is no national requirement for vaccination in the host country and in the country of origin, all horses must have a valid vaccination certificate.

# 3. <u>EQUINE INFLUENZA VACCINATION</u>, VET. REGS. ANNEX VI (Updated 1<sup>st</sup> September)

#### Introduction

Equine Influenza (EI) is a viral respiratory disease which is highly contagious to susceptible horses. Outbreaks of the disease are occurring with increased frequency worldwide despite the widespread use of vaccines. The highly contagious nature of equine influenza means that it has the potential to seriously compromise international movement of horses. For a number of years the FEI rules have required an annual booster vaccination, but recent research indicates that, for many vaccines, protection declines after a few months. This means that towards the end of the vaccination year horses may become increasingly susceptible to infection again, but may not show clinical signs of disease. These cases are particularly dangerous as they can spread virus and could initiate outbreaks of disease.

The requirements for El vaccination will be reviewed annually by the FEI Veterinary Committee and can be altered if the vaccination or disease situation changes.

#### Rule

From 1 January 2005 onwards, influenza vaccination for all horses competing in FEI competitions requires a vaccination within six months + 21 days of the competition. <u>Horses competing regularly consequently require twice yearly boosters</u>. The specific details to accomplish this are provided below:

- 1. All horses that intend to compete in FEI competition must have received at least an initial primary course of two vaccinations, the second dose of which must have been given between 21 and 92 days after the date of administration of the first dose. Thereafter, a third dose (referred to as the first booster) must be given within 6 months +21 days after the date of administration of the second primary dose, with at least annual boosters given subsequently (i.e. within 365 days of the last dose).
- 2. If the horse is scheduled to take part in an FEI competition, the last booster must have been given within 6 calendar months + 21 days of the day of competition or of entry to the FEI stables, whichever is the sooner. (The 21-day window has been provided to enable vaccination requirements to fit in with the competition schedule). <u>Horses competing regularly consequently require twice yearly boosters.</u>
- 3. It is also important that no vaccination should have been given within 7 days of the day of competition or of entry to the FEI stables, whichever is the sooner.
- 4. All horses that were certified as correctly vaccinated under the previous FEI equine influenza vaccination rule prior to 1<sup>st</sup> January 2005, should not need to start a primary course again provided that they have complied with the previous rule of primary course and annual re-vaccinations and the new rule of a booster vaccination within 6 calendar months + 21 days of the day of competition or entry to the FEI stables, whichever is the sooner.

#### Vaccines, Administration and Certification

- All proprietary equine influenza vaccines are acceptable to the FEI irrespective of the route of administration.
- All vaccines must be administered by a Veterinarian.
- The vaccination should be administered according to the manufacturer's instructions (i.e. intramuscular injection or intranasal). The FEI will accept intranasal vaccines for both primary and booster doses. However, it is <u>not</u> possible to change the route of administration between the first and second vaccination of the primary course.
- The details of the vaccine, serial/batch number, the date and route of administration must be recorded in the FEI passport.
- Where vaccination details are to be entered into new FEI passports/recognition cards or duplicates, if the vaccination history of the horse is very long, the Veterinarian who completes the descriptive page of the passport/recognition card may use a specific statement to certify that the vaccinations have been administered in accordance with FEI regulations (for the extract of the wording see Veterinary Regulations, Annex XIV.I.11).

#### **Sanctions**

As from 1 January 2006 a system of fines is being imposed by the Appeal Committee/Ground Jury for failure to comply with 6-month booster vaccinations.

#### and cancellation of the horse's participation in the event.

Fines for other infringements relating to influenza vaccination will be as follows:

- a) If no evidence of any current vaccination in passport: a maximum penalty of CHF 500.-. The horse should not be allowed to compete. It must be put in isolation and sent away from the event as soon as possible.
- b) Any infringements of vaccination dates should be noted in the passport so that it is not reported again at a future event. Please write in CAPITAL letters; remember that others will be dependent on the information that you have written in the passport.
- c) No information available on the primary vaccination course need not lead to a penalty, and a repeat primary course is not required, provided the current passport contains a statement that the vaccination history of the horse has been checked and found to be correct (for exact wording see VR, Annex XIV.I.11).

#### 4. SAMPLING PROCEDURE FOR PROHIBITED SUBSTANCES

("Veterinary Regulations", Chapter V & VI and Annex IV)

Regular sampling is carried out in CCI\*\*\*/\*\*\*\*, CCIOs, World Cup Qualifiers and Finals, Championships and Games, whereas at other CCIs sampling is recommended. In CCIs\*\*\*\*/\*\*\*, the number of horses tested is at the discretion of the Testing Veterinarian/Veterinary Delegate; however, a minimum of three is recommended (Vet. Regs. Art. 1016)

Special guidelines are applicable for events covered by the FEI Medication Control Programme (Groups I & II only).

#### 5. MEDICATION CONTROL PROGRAM (only in groups I et II).

Competitors at FEI events within Groups I & II must pay the equivalent of Sfr 12,50 per horse per event to the O.C. towards the costs of the above program.

Under the Medication Control Programme (MCP) in **Groups I and II**, all samples collected in accordance with Vet. Regs. Art. 1016 will be analysed by the **HFL Sport Science**, **Quotient Bioresearch Limited**, **Newmarket Road**, **Fordham**, **Cambridgeshire**, **CB7 5WW**, **UK**. For events other than those listed in Vet. Regs. Art. 1016 or for events other than in Groups I and II, samples may be analysed at an alternative FEI listed laboratory (Vet. Regs. Art. 1021).

## XIII - MISCELLANEOUS

#### 1. COMPLAINTS

To be valid, all complaints must be recorded in writing and be accompanied by a 150 SFr deposit (FEI rules).

#### 2. DOCTOR, VETERINARIAN, FARRIER

Medical and veterinary assistance, as well as farrier services will be paid by the owners, riders, or concerned persons. The Organising Committee will not intervene in those settlements.

#### 3. MEDICAL CARD (ANNEX 7 OF THE "RULES FOR EVENTING")

The OC draws the attention of all competitors that they must carry readily accessible on themselves a medical card (see Annex I of this Check List) for the Cross-Country Test. Armbands will be checked by the OC upon arrival to the competition by the riders and checked by the Official Doctor and the Technical Delegate for accurate information.

## **4. INSURANCES**

All owners and competitors are personally responsible for damages to third parties caused by themselves, their employees, their agents or their horses. They are therefore strongly advised to take out third-party insurance providing full coverage for participation in equestrian events at home and abroad, and to keep the policy up to date.

Would a competitors insurance fail to provide proper compensation the organiser's civil liability insurance should in no case be applied.

Further competitor's horses and personal equipment is their own responsibility throughout the event. They must also cover the repatriation costs in case of accident.

Consequently, participants waive all claims they could enact against the organiser.

**LIABILITY**: the Organising Committee and its representatives can not be held responsible for damage, material, physical or incurred by accident caused by other competitors, their horses, or assistants. Carriage, harness, stable equipment and others' damage (including theft or loss) stewards' responsibility.

In cases not properly covered, no claims could be made against the Organising Committee liability insurance.

#### 5. EVENT'S ORGANISATION

The Organising Committee reserves the right to apply any correction to this Schedule made necessary by inexact interpretation or omission or unpredictable circumstances (Art. 114, 115 of the G.R., in agreement with the F.E.I.).

## XIV - CODE OF CONDUCT

# THE FEI CODE OF CONDUCT FOR THE WELFARE OF THE HORSE

The Fédération Equestre International (FEI) expects all those involved in international equestrian sport to adhere to the FEI's Code of Conduct and to acknowledge and accept that at all times the welfare of the horse must be paramount and must never be subordinated to competitive or commercial influences.

- 1. At all stages during the preparation and training of competition horses, welfare must take precedence over all other demands. This includes good horse management, training methods, farriery and tack, and transportation.
- 2. Horses and competitors must be fit, competent and in good health before they are allowed to compete. This encompasses medication use, surgical procedures that threaten welfare or safety, pregnancy in mares and the misuse of aids.
- 3. Events must not prejudice horse welfare. This involves paying careful attention to the competition areas, ground surfaces, weather conditions, stabling, site safety and fitness of the horse for onward travel after the event.
- 4. Every effort must be made to ensure that horses receive proper attention after they have competed and that they are treated humanely when their competition careers are over. This covers proper veterinary care, competition injuries, euthanasia and retirement.
- 5. The FEI urges all involved with the sport to attain the highest levels of education in their areas of expertise.
